The Society of Vertebrate Paleontology By-Law on Ethics

"Article 12. Statement of Ethics.

Several goals for the Society of Vertebrate Paleontology follow from its mission statement (Constitution Article 1): to discover, conserve, and protect vertebrate fossils and to foster the scientific, educational, and personal appreciation and understanding of them by amateur, student and professional paleontologists, as well as the general public. Fossil vertebrates are usually unique or rare, nonrenewable scientific and educational resources that, along with their accompanying contextual data, constitute part of our natural heritage. They provide data by which the history of vertebrate life on earth may be reconstructed and are one of the primary means of studying evolutionary patterns and processes as well as environmental change.

- It is the responsibility of vertebrate paleontologists to strive to ensure that vertebrate fossils are collected in a professional manner, which includes the detailed recording of pertinent contextual data (e.g. geographic, stratigraphic, sedimentologic, taphonomic).
- It is the responsibility of vertebrate paleontologists to assist government agencies in the development of management policies and regulations pertinent to the collection of vertebrate fossils, and to comply with those policies and regulations during and after collection. Necessary permits on all lands administered by federal, state, and local governments, whether domestic or foreign, must be obtained from the appropriate agency(ies) before fossil vertebrates are collected. Collecting fossils on private lands must only be done with the landowner's consent.
- Fossil vertebrate specimens should be prepared by, or under the supervision of, trained personnel.
- Scientifically significant fossil vertebrate specimens, along with ancillary data, should be curated and accessioned in the collections of repositories charged in perpetuity with conserving fossil vertebrates for scientific study and education (e.g. accredited museums, universities, colleges, and other educational institutions).
- Information about vertebrate fossils and their accompanying data should be disseminated expeditiously to both scientific community and interested general public.
- The barter, sale, or purchase of scientifically significant vertebrate fossils is not condoned unless it brings them into, or keeps them within, a public trust. Any other trade or commerce in scientifically significant vertebrate fossils is inconsistent with the foregoing, in that it deprives both the public and professionals of important specimens, which are part of our natural heritage."

\$ _____ **General Donations** (GE_DONATE)

In 1986, the Society established this fund to meet the needs of the science as determined annually by the Executive Committee. Initially, the income was applied largely to support the Bibliography of Fossil Vertebrates. In recent years, unrestricted donations have been used to support other strategic initiatives of the Society.

\$ _____ **The Vertebrate Paleontology Education and Research Fund** (EDU_FUND)

The Vertebrate Paleontology Education and Research Fund is a fund created to support ongoing as well as major new initiatives.

\$ _____ **Colbert Award Fund** – Previously known as the Student Poster Prize (ST_POSTER)

Established to recognize the best student poster presentation at the SVP Annual Meeting.

\$ _____ **Estes Memorial Grant Fund** (ESTES)

The Richard Estes Memorial Grant Fund was initiated in 1992 as a vehicle to provide an annual award for a graduate student working in Dr. Estes' area of interest, namely "lower" vertebrate paleontology.

\$ _____ **SVP Sponsored Field and Topical Conferences Fund** (GE_CONFERENCE)

Established in 2005 to support advancement of the science of vertebrate paleontology through field and topical conferences.

\$ _____ **Government Affairs Fund** (GOV)

Supports monitoring and education programs related to legislation and government programs that impact vertebrate paleontology.

\$ _____ **Jackson School of Geosciences Student Member Travel Grant Fund** (STUDENT_TRAVEL)

Established in 2005 to support student travel to attend and present their research at the SVP annual meeting.

\$ _____ **Lanzendorf PaleoArt Prize** (LANZ_TEMP)

The John J. Lanzendorf PaleoArt Fund was established to recognize outstanding scientific illustration or naturalistic art pertaining to vertebrate fossils.

\$ _____ **Patterson Memorial Grant Fund** (PATTERSON)

The Bryan Patterson Memorial Grant Fund supports innovative student field work in vertebrate paleontology. Both undergraduate and graduate students are eligible to apply.

\$ _____ **Predocctoral Fellowship Grant Fund** (PRE_DOC)

Supports an outstanding advanced graduate student the opportunity to further their studies in vertebrate paleontology.

\$ _____ **Preparators' Grant Award Fund** (PREP)

The Preparators' Grant Award Fund was established to further the field of vertebrate paleontology through preparation and study of methods and materials used to reveal and preserve fossil information. The award has provided members funding for preparator training, material and equipment for preparation laboratories, research and publication emphasizing preparation and support for presentations at the annual SVP Preparation, Material and Methods Symposium.

\$ _____ **Romer Prize Fund** (ROMER_FUND)

The Alfred Sherwood Romer Prize was established to recognize outstanding scientific contributions in vertebrate paleontology by predoctoral students. Because Professor Romer epitomized the highest qualities of scientific communication, this fund supports an annual award for predoctoral students who are conducting important research in vertebrate paleontology and who present their high quality research at the SVP Annual Meeting.

\$ _____ **Skinner Award Fund** (SKINNER)

The Morris F. Skinner Award Fund was created to recognize outstanding and sustained contributions to scientific knowledge through the making of important collections of fossil vertebrates-it shall also be made to those persons who encourage, train, or teach others toward the same pursuits.
